GENERAL TERMS AND CONDITIONS OF CONTRACT

Applicable regulations

In signing this registration form the exhibitor acknowledges the following Regulations of MCH Swiss Exhibition (Zurich) Ltd. as binding: Exhibition and General Regulations, Logistics Regulations, Stand Constructions Guidelines and the Data protection declaration. MCH Swiss Exhibition (Zurich) Ltd. reserves the right to issue and enforce further regulations and instructions in individual cases.

Payment in advance (deposit)

An advance payment will be charge for additional services, such as technical connections (electricity, installation of suspended items, water), rented furnishings, the compulsory entry in the Giardina catalogue system (CHF 680), parking spaces, admissions tickets, vouchers etc., together with the invoice on account (for a main exhibitor CHF 1,000). This advance payment will be offset after the exhi-bition by the actual costs by means of a final invoice.

Technical connections and other services

All order forms can be found in our internet-based ordering service at www.m-manager.com. After allocation of the stand site, exhibitors will receive the contract confirmation and further information about «m-manager». The setting up of technical connections and other work will only be carried out when requested using the appropriate forms. The basic entry (basic package) in the Giardina catalogue system is compulsory for every exhibitor and co-exhibitor.

Evening events

The exhibitor acknowledges and agrees to closed evening events being staged in the exhibition halls outside normal business hours.

Data protection

MCH guarantees data protection in accordance with the Swiss Data Protection Act, the EU General Data Protection Regulation and theData Protection Declaration of MCH Group Ltd. The exhibitor's personaland company data will be processed by MCH or by commissioned third parties for purposes of handling the contract, customer care and market research. In addition, MCH makes this data available to other subsidiaries of MCH Group Ltd., foreign representations of MCH Group Ltd. and external service partners for purposes of establishing contact and providing services in conjunction with the exhibitor's participation in the exhibition. The exhibitor gives his/her consent to this insofar as no express objection has been lodged.

Confirmation of the contract by the Exhibition Management

On receipt of this registration, the Exhibition Management will send a separate confirmation of the definitively allocated stand. With this confirmation of the contract (CC), all the different parts of the contract will become legally binding. The confirmation of contract forms an integral component of the Exhibitor's Contract.
